Our conference offers 15 different tracks, which allows participants to contribute to our ongoing academic debate from different angles. This includes exploration at the system level, organizational level, organizational impact and exploring methodological and theoretical foundations. Authors are invited to submit *extended abstracts* (700 – 1200 words), *short papers* (approx. 2500 words) or *full papers* (up to 6000 words) until 1st of February 2023 through the registration and submission system (ConfTool).

All accepted and timely (re-)submitted contributions (when needed) will be referenced in the conference proceedings. Contributions must be submitted to one of the proposed track sessions mentioned below. Authors should refer to the submission guidelines and templates available at the NBM2023 website.

Deadlines

- Full call for papers: Oct 24st, 2022;
- Deadline for submissions: Feb 1st, 2023;
- Review process: Feb 1st to March 1st 2023;
- Notification to authors: March 10th 2023.

Submissions will be handled through the ConfTool system. This system will be available soon on our conference website.
